

ORDINANCE No. 186537

*Accept and appropriate a grant in the amount of \$200,000 from the Oregon Department of Transportation to commence Graffiti Abatement along areas of Martin Luther King Jr. Blvd / Grand Ave Viaduct (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. On October 22, 2003, the Portland City Council passed Ordinance No. 177983, transferring ownership of the MLK Viaduct replacement project upon completion to the City of Portland. That ownership was accepted by the City of Portland's Bureau of Transportation on Feb 7, 2014.
2. The Oregon Department of Transportation agreed to pay the City of Portland a sum not to exceed \$200,000 to paint the graffiti prone walls and abutments to the Viaduct for graffiti abatement.
3. The Bureau of Transportation plans to use this sum to paint the bridge during the summer of 2014.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation in the amount of \$200,000, and the Commissioner-in-Charge and the Auditor are authorized to execute an Intergovernmental Agreement with the Oregon Department of Transportation to secure the funding in a form similar to the contract attached as Exhibit A.
- b. The FY2013/2014 budget is hereby amended as follows:
Grants Fund
Fund: 217
Business Area: TR
Bureau Program Expense: \$20,000
- c. The OMF Grant's Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Commissioner-in-Charge's behalf.


