The Hillside Community Center currently serves more than 50 families through the preschool program offered Monday through Friday to children in the community, ages 2-5. For over ten plus years, the preschool classroom located in the southwest lower level of the community center, floods during the heavy rains. For example, in the 2012/2013 school year, the room flooded eight times. When the flooding occurs, the preschool classes are cancelled or when possible, moved to other locations in the building. This creates more challenges as the facility, is already at capacity. Over the years, the flooding has destroyed multiple rugs, classroom future and educational equipment due to the deterioration from rust and wood damage. Due to the elevated moisture levels in the room when the flooding occurs, mold spots are appearing on the walls causing unsafe conditions for young children and the floor needs to be replaced.

Portland Parks and Recreation has tried several methods to fix the problem including, installing a sump pump, waterproofing the space between the sidewalk and building and most recently installing a French drain underneath the sidewalk. Unfortunately, the repairs have met with little success and PP&R lacked the financial resources to accurately fund a project of this magnitude. Since the 2012/2013 budget year, Hillside Community Center no longer receives general fund support and the community center is required to be financially self sustaining. A request has been submitted for a Capital Improvement Project but due to other projects on the priority list, funding would not be available until 2018. With funding assistance from the NW Neighborhoods Parks and Recreation Fund, Hillside Community Center would be able to fund the construction costs to properly waterproof the foundation and install a drainage system to divert the water from the building in order to protect the assets that are deteriorating from the constant water damage.

PROJECT NARRATIVE

Designed in the 1940s by noted local architect Pietro Belluschi, the community center originated as the Catlin Gabel School. After the school moved, the Portland Art Association purchased the property for use as an artists' cooperative. Finding the property too costly to maintain, the Art Association decided to sell it, and word spread that the most likely buyer was a developer of condominiums. Since many of the homes in the area are situated on steep lots with no backyards, residents felt that the site would be better used as a park and community center. The community was given a year to raise \$106,500 to purchase the land and the buildings on it. After an exhaustive neighborhood fundraising effort, plus contributions from the City Council and private foundations, the community was still \$25,000 short.

To make up the difference, twelve families took out second mortgages on their homes to guarantee the loan that finalized the purchase. In spring of 1974, the neighbors turned the property over to the City of Portland, which accepted it as a public park and agreed to maintain it and staff a community center there.

What specific recreational needs does the project meet and how were they

determined? Hillside Community Center serves over 50 families yearly in the pre-school program offered Monday through Friday. The project would give the preschoolers a consistent learning environment to engage in enriching activities to further their growth and development. Unexpectedly changing a child's environment to a non classroom space like the gymnasium creates an unstable situation which leads to a disruptive learning experience.

What specific members of the community will benefit from the project? Hillside Community Center serves the entire NW community. Located in a dense neighborhood with limited parks, this location has a high level of use from the immediate community, as well as the families of neighboring schools. The Hillside Community Center severs 25,000 people yearly.

How has community support been developed for the project? The Hillside Neighborhood Associations is supportive of the project and it was their recommendation that Hillside apply for funding. Attached are three letters of support from parents whose children have been affected by the flooding problem and are encouraged about the project opportunity.

Why is your organization the most appropriate one to pursue this project? Portland Parks & Recreation is the property owner and manages the staff on-site. Neighborhood supported grant opportunities like this allow community centers the ability to leverage community support for needed projects.

How will you leverage other resources for the project, including financial, volunteer and in-kind contributions? The Hillside Neighborhood Association has been supportive of this project and they have the resources to work with the community to possibly find other funding sources. PP&R staff would be available to assist with the project scope and design.

It may also be possible to solicit funds through the Hillside Neighborhood and the community center users.
