### 1) Legislation Title:

\* Change the application timing requirements of the Multiple-Unit Limited Tax Exemption Program (Ordinance; amend Code Section 3.103.040)

### 2) Purpose of the Proposed Legislation:

This Ordinance amends City Code 3.103 for the Multiple-Unit Limited Tax Exemption (MULTE) program to change the application timeframe that developers of multi-family projects need to meet in order to be eligible for the program. With the change, developers will be able to apply for a building permit at the same time they have an application under review for the MULTE program, rather than waiting to apply for a building permit until the MULTE is approved. Developers will still need to wait for approval of the MULTE before being able to have permits issued and begin construction.

Although the change approved by the Ordinance should allow more applicants to access the program, it is primarily an administrative change, and the program still has a cap in place which limits the amount of approved foregone revenue each year to no more than \$1 million of approved projects' first year of estimated exempted taxes.

This action will allow more developers to access the program because the timing will better fit within their development schedules.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved? Commissioner Saltzman and his staff, as well as the PHB Director, Traci Manning, and Assistant Director, Javier Mena, and PHB staff have received extensive feedback from both for-profit and non-profit developers and other housing organizations such as Oregon Opportunity Network expressing concern about the current application timing of the MULTE program since the guideline went into place in 2012. PHB staff also communicated with Multnomah County staff at the same time Commissioner Saltzman engaged the County Chair to confirm the County agrees with the change to the program.

### c) How did public involvement shape the outcome of this Council item?

Part of the feedback received by the City resulted from proactive conversations initiated by PHB which resulted in this change being identified as one of the primary deterrents to more developers choosing to apply for the program and agreeing to provide affordability in otherwise market-rate housing.

The public involvement was led primarily by Commissioner Saltzman's office and the PHB Director.
