ORDINANCE No. 186553

*Create a new represented classification of Site Operations Crew Leader and establish an interim compensation rate for this classification. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating a new represented classification effective October 22, 2013.
- 2. The business needs that this classification is intended to meet cannot be fulfilled until the classification and wage rate is established, however the wage rate for the classification must be collectively bargained with District Council of Trade Unions (DCTU), Laborers' International Union, Local 483. Under Article 27.5.2 of the DCTU contract, the City may establish interim rates during bargaining.

NOW, THEREFORE, the Council directs:

a. The following classification is being created:

b. The following interim compensation rate is established:

Pay Scale	<u>Entry</u>	<u>1 year</u>
SCL02425	\$26.23	\$28.51

- c. The City and DCTU are completing successor contract negotiations. The compensation rate established above will be changed to reflect relevant adjustments resulting from the collective bargaining process.
- d. When the City and DCTU conclude necessary bargaining over the appropriate salary rates, the rates may be implemented with no further action upon signing of a Memorandum of Agreement between the Director of Human Resources and DCTU and approval as to form by the Office of the City Attorney.
