Ordinance Title:

Assess benefited properties for street and stormwater improvements from south of NE Whitaker Way to north of NE Prescott Ct in the NE 136th Ave Phase I Local Improvement District (Second Reading Agenda 375; C-10036)

Purpose of Amendment:

This amendment directs the Local Improvement District (LID) Administrator to schedule a separate and subsequent Council hearing for the NE 136th Avenue Phase II LID. There would be no delay to final assessment of the NE 136th Avenue Phase I LID while this work on a separate and subsequent LID for NE 136th Avenue begins.

Effect of Amendment:

The effect of the amendment is to initiate formation of the NE 136th Avenue Phase II LID by Council prerogative instead of by petition by the property owners. Council may not form the NE 136th Avenue Phase II LID within a 6-month period under City Code if owners of 60% or more of the properties remonstrate against LID formation. Note that Council is not obligated to actually form the new NE 136th Avenue Phase II LID irrespective of the remonstrance level.

No change would be made to the apportionment of assessments, including for costs of reconstructing the northernmost 80 feet of NE 136th Avenue south of NE Whitaker Way, as disclosed and budgeted in the LID petition, and as approved by Council per Resolution No. 36803 approved on July 28, 2010 and per Ordinance No. 184090 on September 1, 2010.

Ordinance

Add directive 'd':

"The Council directs the Local Improvement District Administrator to initiate local improvement district formation proceedings to construct street, sidewalk and stormwater improvements from the north property line of 4525 NE 136th Avenue to the south right-of-way line of NE Prescott Court, including a new curb on the south side of NE Prescott Court, plus any other transition improvements on NE Prescott Court abutting 4417 NE 136th Avenue and 13644 NE Prescott Court determined to be necessary by the City Engineer."

New emergency clause:

Section 2. The Council declares that an emergency exists because a delay in passage would delay issuance of Notices of Final Assessment, which in turn would delay property owners' ability to pay off liens; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
