## CONSENT CALENDAR

TO THE COUNCIL:

The Chief Procurement Officer has advertised and received bids for Bid Number 116569 for SE 122nd Ave: SE Market St to SE Stark St for the Bureau of Transportation Engineering and Development, with a project construction estimate of \$847,379.00. The Bureau of Transportation Engineering and Development rated the level of project estimate confidence as Moderate.

Bids were opened on April 1, 2014, and seven (7) bids were received. The low bid of Knife River Corporation - Northwest was deemed responsive to the requirements of the solicitation. Therefore, it is recommended that the bid of Knife River Corporation - Northwest be accepted at the unit price quoted in their bid for a total estimated amount of \$650,321.16.

The Bureau of Transportation Engineering and Development along with Procurement Services, identified nine (9) Divisions of Work as potential M/W/ESB subcontracting opportunities for this project, resulting in \$168,559.13 awarded to subcontractors.

It is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final contract amount be furnished by the Contractor before final payment is released.

The bid sureties of the remaining bidders should be returned immediately in compliance with Section 5.34.410D of the City Code.


