Purpose of Agenda Item: This Ordinance provides Council authorization to the Bureau of Planning and Sustainability to provide \$20,000 to Metro for regional transportation modeling services that are necessary for the City of Portland to update its transportation model as part of the Transportation System Plan update			

6. History of Agenda Item/Background: As part of state-mandated Periodic Review, the City of Portland is required to update the Transportation System Plan (the TSP). As a joint project of BPS and PBOT, the City is required to model the performance of the proposed comprehensive plan map and transportation system network in order to demonstrate compliance with State and regional transportation performance standards. The City's transportation model must be coordinated with Metro's regional transportation model. Therefore, Metro provides modeling services to provide the basic inputs (trip volumes, mode, length, etc) that are used in the City's transportation model. Metro provides a limited level of support through its Technical Assistance Fund, but the work for the TSP is expected to exceed the available funds.
