

ORDINANCE NO. 186563

- * Authorize an Intergovernmental Agreement with Home Forward, Multnomah County, and the City of Gresham for the use of Payment in Lieu of Taxes funding in the amount of \$200,000 funded directly to the Short Term Rent Assistance program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Payment in Lieu of Taxes (PILOT) funds are a voluntary payment that housing authorities make to local taxing jurisdictions.
2. A 2003 PILOT intergovernmental agreement (IGA) committed the participating jurisdictions to developing a flexible and outcome based rent assistance delivery system. The result of this commitment was the development of the consolidated Short Term Rent Assistance (STRA) program administered by Home Forward, which continues to operate currently. The 2003 PILOT IGA expired on June 30, 2013.
3. The participating jurisdictions and Home Forward desire to enter into a new ten-year term IGA that continues the work and collaboration of the 2003 PILOT IGA.
4. Home Forward will continue to provide PILOT for housing assistance to end or prevent homelessness from July 1, 2013, to June 30, 2023, in the form of \$200,000 in annual contributions directly to the consolidated STRA program.
5. Home Forward will provide annual reports to the City of Portland, the City of Gresham, and Multnomah County on the performance of the STRA program. These reports will include information on the number and demographics of households served and information on housing retention and outcomes for households assisted at 3, 6, and 12 months after the end of assistance.

NOW, THEREFORE, The Council directs:

- a. The Commissioner of Public Affairs is hereby authorized to enter into an Intergovernmental Agreement with the Home Forward, Multnomah County, and the City of Gresham for the annual allocation of PILOT for housing and homeless activities, in a form substantially in accordance with the Agreement attached as Exhibit A (attached to original ordinance only).

Section 2. The Council declares that an emergency exists so that there will be no delay in the delivery of services; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
