## ORDINANCE No. 186567

\* Accept a grant in the amount of \$37,500 and appropriate \$10,000 for FY 2013-14 from the Oregon Department of Transportation, Transportation Safety Division 2014 Multnomah County DUII Intensive Supervision Program for sworn personnel overtime (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The Police Bureau applied to the Oregon Department of Transportation (ODOT) for a grant in the amount of \$37,500 for the 2014 Multnomah County DUII Intensive Supervision Program (DISP) on September 17, 2013; and
- 2. The Oregon Department of Transportation notified the City on March 11, 2014, that it will award a grant for the 2014 DUII Intensive Supervision Program to the Police Bureau in the amount of \$37,500; and
- 3. The ODOT project will fund the Police Bureau Traffic Division so they may assist the Multnomah County DUII Intensive Supervision Program by providing direct law enforcement capability to the court-based probation program. The primary function of the sworn members will be to conduct warrant sweeps; and
- 4. The Oregon Department of Transportation will reimburse the City a maximum of \$37,500 for sworn personnel overtime expenses worked on the 2014 DISP grant during the bureau's grant period May 23 September 30, 2014; and
- 5. Local match in the amount of \$112,500 will be provided by funds from FY 2013-14 and FY 2014-15 bureau program budget appropriations; and
- 6. Council declares an emergency exists because a delay would jeopardize the awarding of the grant funds from ODOT.

## NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation for the 2014 Multnomah County DUII Intensive Supervision Program in the amount of \$37,500.
- b. The FY 2013-14 budget is hereby amended as follows:

**GRANTS FUND** 

Fund - 217

Business Area - PL

Bureau Program Expenses - \$10,000

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City any subsequent modifications by the Oregon Department of Transportation for the 2014 Multnomah County DUII Intensive Supervision Program, K8-14-12-17, provided such modifications do not increase the City's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would jeopardize the awarding of the grant funds from ODOT. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
