The Portland Rose Festival is a regional annual event. The Portland Rose Festival Foundation and the events that it sponsors are an integral part of the community. This ordinance provides revocable permits to the Portland Rose Festival Foundation to conduits activities. These include permits for the Grand Floral, Junior and Starlight parades; use of Tom McCall Waterfront Park; street closures for formation and disband areas for Grand Floral Parade and the hanging of banners on ornamental light standards. While not City revenue, an economic study commissioned by the Portland Rose Festival Foundation indicates that the 2012 Rose Festival and sanctioned events generated \$75.5 mill in economic impact. 3) Which area(s) of the city are affected by this Council item? This legislation will not generate or reduce current or future revenue coming to the City. Council has historically voted in favor of absorbing some of the costs associated with the Rose Festival events and waiver of some fees. These revenues are included in current year appropriations.

The Revenue Bureau will collect permit fees of \$9,270.00 for year 2014 permits, as per the special event administrative regulations. These funds are distributed; \$4,635 to Police, \$2,781 to Portland Bureau of Transportation, and \$1,854 to the Revenue Bureau, as compensation against the special event expenses incurred. Shown in Expense Section 5. However, as with other special events; these fees do not cover true costs for the parades.

The Portland Bureau of Fire and Rescue (PF&R) will collect an estimated \$1,500.00 for the inspections done at the Waterfront CityFair, \$150 permit fee for the Fireworks Show, and standby fees for PF&R personnel for both concert and fireworks shows

Portland Parks and Recreation estimates collection of \$152,000 in revenues as reimbursement for use and repairs of Waterfront Park for CityFair.

The Bureau of Development Services permit and inspection fees are waived.

- Junior Rose Festival Parade \$25,105

- Festival Center \$8.245
- Miscellaneous services such as harbor wall preparation, drop box painting, and building barricades \$51,421

7. BACKGROUND / ANALYSIS

This ordinance provides revocable permits to the Portland Rose Festival Association to conduct its activities. These include permits for the Grand Floral, Junior and Starlight parades; use of Tom McCall Waterfront Park; and street closures for formation and disband areas for Grand Floral Parade.

8. FINANCIAL IMPACT

This legislation will not generate or reduce current or future revenue coming to the City. Council has historically voted in favor of absorbing some of the costs associated with the Rose Festival events and waiver of some fees. Estimates of City revenues for 2014 include:

- The Revenue Bureau will collect permit fees of \$9,270.00 for year 2014 permits, as per the special event administrative regulations. These funds are distributed; \$4,635 to Police, \$2,781 to Portland Bureau of Transportation, and \$1,854 to the Revenue Bureau, as compensation against the special event expenses incurred. However, as with other special events; these fees do not cover true costs for the parades.
- The Portland Bureau of Fire and Rescue (PF&R) will collect an estimated \$1,500.00 for the inspections done at the Waterfront CityFair, \$150 permit fee for the Fireworks Show, and standby fees for PF&R personnel for both concert and fireworks shows.
- Portland Parks and Recreation estimates collection of \$152,000 in revenues as reimbursement for use and repairs of Waterfront Park for CityFair.

Estimated expenditures for 2014, based on reported 2012-2013 costs, include:

Police Bureau costs associated with Rose Festival events are \$257,118, as detailed below:

- Grand Floral Parade \$80,303
- Junior Rose Parade \$23,664
- Starlight Parade/Run \$73,478
- Festival Center \$70,137
- Other miscellaneous Rose Festival costs \$9,536

Portland Bureau of Transportation costs associated with Rose Festival events are \$158,254, as detailed below:

- Grand Floral Parade \$56,001
- Junior Rose Festival Parade \$25,105
- Starlight Parade \$17,482
- Festival Center \$8,245
- Miscellaneous services such as harbor wall preparation, drop box painting, and building barricades \$51,421

An economic study commissioned by the Portland Rose Festival Foundation indicated that the 2012 Rose Festival generated \$75.5 million in positive economic impact, bringing over a million visitors to Portland.
