ORDINANCE No.

*Authorize a grant agreement for \$100,000 with David Douglas School District to support the Earl Boyles Early Works program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. David Douglas School District (DDSD) serves over 10,500 students annually in outer southeast Portland, Oregon. The District is constructing an early childhood learning wing and family support center at Earl Boyles Elementary School where 80% of the children qualify for free or reduced lunch.
- 2. The Earl Boyles Early Works program is targeted to prevent achievement gaps by providing access to early learning programs for children from birth to age five with prekindergarten and kindergarten classrooms.
- The program also includes a family resource center which will serve at least 2,790 people with 1,140 hours of programming. Based on current demographic information, those accessing the Neighborhood Center will be 90% low income, 60% people of color, and 23% new Portlanders from immigrant and refugee communities.
- 4. City Council approved an allocation of \$100,000 General Funds in the 2013-2014 Adopted Budget to support the Earl Boyles Early Works capital campaign.
- 5. The program is also supported by the David Douglas School District General Obligation Bond, Multnomah County, Portland Development Commission, private foundations, and individual donations.

NOW, THEREFORE, the Council directs:

- a. The City of Portland is hereby authorized to enter into a grant agreement substantially similar to Exhibit A.
- b. The Mayor and City Auditor are authorized to draw and deliver \$100,000 to DDSD.

Section 2. The Council declares that an emergency exists because delay in funding would delay the project's scheduled completion for Autumn 2014; therefore this ordinance shall be in full force and effect from and after its passage by the Council.
