Dear Mayor Hales and Portland Commissioners,

I am here today to ask Mayor Hales for help to make Portland Police Commander Day and Police Chief Reese make some Tigard police officers **stop** shooting me every day, 20-24 hours a day with mainly microwave weapons, also with ultrasound weapons, voice to skull command weapons, and other weapons. They have been burning, injuring me and giving me pain and tissue and skin destruction with these for more than two years, and a few years before that but less often. My ex-neighbor lady Tami Laurson calls these Tigard cops up every day and also tells them where to shoot me and my son or what to say to me including death threats.

I wrote you two letters requesting an appointment with you Mayor Hales because me testifying about this for three minutes, that is mostly a one-way conversation, is not enough time to resolve these crimes. Because Sgt. Eskew, Lt Rhodes and other Tigard cops shoot me ~~so~~ 24 hours a day their intent is obviously not just to harass me, but to murder me <sup>and they've said that.</sup> That is attempted murder and that is what Commander Day, Police Chief Reese, Sgt. McCamick and other Portland Police officers are covering up. That is, they are doing nothing to stop these assaults therefore they are doing facilitation of murder. Sgt. Eskew, Lt. Rhodes and other Tigard cops have told me many times they're shooting my son with microwave and ultrasound when he's sleeping to give him cancer.

Your assistant Grace wrote me a letter saying you would not meet with me but referred me to the Independent Police Review to file a complaint. <sup>I called her, but she is not, Eric Bony is investigating</sup> Grace didn't say why you wouldn't meet with me. It seems she may be screening some of your letters addressed to you, deciding herself what problems or crimes are worthy of your time to make an appointment with you. I think most people would agree that when someone writes you a

letter about attempted murder cover up by Portland Police officers, you should read that letter yourself since you are the mayor and the Police Commissioner.

Most of the assaults are done to me in Portland so I've usually reported these crimes here at Central Precinct. Many of the officers I've reported this to have falsified some of their police reports and left out evidence I told them or showed them as a way to discredit me, to justify not doing anything to stop these assaults and threats.

They are covering up for these assaults and attempted murder because of the kinds of weapons those Tigard cops are shooting me with. Some of those cops don't want the public to know they and other jurisdictions' cops have weapons they can shoot us with remotely, that burn, injure, mutilate, and psychologically and emotionally influence, and they work through walls, floors, and ceilings. Those technologies can be verified by looking them up on the internet. Most of the websites are credible but they do have some disinformation websites.

I have burns and scars all over my ankles, legs, and other places from them shooting me and skin deterioration all over from them shooting me with microwave and ultrasound. The ultrasound <sup>weapons</sup> ~~causes~~ breaks up the collagen in the skin and also causes deep tissue pain.

They have these <sup>weapons set up</sup> in <sup>Reese Mission</sup> SAFE's women's shelter, TPI winter shelter, Starbucks, Pioneer Courthouse Square, Whole Foods, Fred Meyers, First Baptist Church, St. Michael's Church in Portland, Christ the King church in Tigard, in front of and inside Multnomah County Courthouse, Multnomah County library and other places I go. They have hundreds of other targets. They've told me they love to harass and torture people, but they also murder a lot of people. Sometimes as I read the Oregonian they make comments to me indicating they used voice to kill weapons on that person to make him commit a murder, or suicide.

You have the authority to make Portland Police officers stop this ~~attempted~~ murder to me and my son. Please listen carefully to Reese's, Commander Dey's and Sgt. McCamie's responses to you if you ask them about this. I do have enough evidence to have those Tigard cops arrested and prosecuted and those Portland cops knew those Tigard cops are shooting me with those weapons. If they deny it, they are fibbing.

Reason for the request:

I want to discuss the more than two year extreme harassment to me by some Tigard cops mainly, who shoot me daily, 20-24 hours a day with microwave harassment weapons, ultrasound harassment weapons, voice to skull command weapons, and others. There are some Portland Police officers covering up for this attempted murder to me, some Tigard cops have said to me several times they're shooting my son with these when he's sleeping to give him cancer. Because they shoot me so often (these weapons they set up remotely) their intent is obviously not just to scar and burn me, but to murder me and they've admitted that many times. There burn scars all over my legs, ankles and other places, skin destruction, etc from these weapons. Anyone can verify these weapons exist by looking them up on the internet. Most cops are told by their bosses to deny the existence of these weapons.

- You will have 3 minutes to speak and may also submit written testimony before or at the meeting. Communications allow the Council to hear issues that interest our citizens, but do not allow an opportunity for dialogue.
