

ORDINANCE No. 186588

*Authorize an Intergovernmental Agreement with PSU Community Environmental Services in the amount of \$15,000 for Curbside Garbage and Recycling Collection Renter Outreach.
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. By Resolution 36423 on June 28, 2006, Portland City Council adopted goals for a sustainable solid waste and recycling system to:
 - Promote sustainability of the solid waste and recycling system that includes maximum efficiency, equity and economic vitality, improved worker safety and reduced environmental and human health impacts over the entire life cycle of the materials, and
 - Minimize the impact of harmful wastes by targeting toxicity and reducing greenhouse gases emissions, and
 - Reduce per capita waste generation below 2005 levels by the year 2015, and
 - Maximize recovery of all waste with a target of 75% by the year 2015 and promote highest value use of recovered materials and;
2. Resolution 36918 on April 25, 2012, the Equity initiative in the Portland Plan provides a framework for the City's overall equity strategy. The Portland Plan includes a framework for Equity to guide, plan implementation and improve City operational and business practices, support actions that promote accountability, close disparity gaps and increase community engagement in civic activities;
3. Renters of single family houses and small plexes (2-4 units) have less access to information on the curbside collection system because bills are sent to property owners.
4. The Bureau of Planning and Sustainability is proposing working with PSU Community Environmental Services to conduct door-to-door outreach and site surveys.
5. The purposes of the outreach effort to provide information to renters who live in homes and small plexes (2-4 units).
6. The City of Portland's contribution to the project for the Fiscal Year 2013-2014 is \$15,000. Funds are available in adopted FY 13-14 budget for the Bureau of Planning and Sustainability,

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute an Intergovernmental Agreement with PSU in a form substantially in accordance with the agreement attached and referenced as Exhibit 1.

- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Bureau of Planning and Sustainability, Cost Object 9PNSWR000004 when demand is presented and approved by the proper authority.
- c. The Director of the Bureau of Planning and Sustainability is hereby authorized to sign amendments for continuing data management, reporting and funding in future fiscal years if appropriations are approved by City Council.

Section 2. The Council declares that an emergency exists in order to forward funds for services to continue work that benefits the City. Therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
