

ORDINANCE No. 186589

Authorize a three-year Intergovernmental Agreement with Portland State University in the amount of \$135,000 to execute the Multifamily Recycling Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Both the State of Oregon and the City of Portland have adopted aggressive waste reduction goals that rely on increasing recycling for all sectors, residential, multifamily and commercial.
2. City Council adopted Resolution No. 36423 which established the following goals for the solid waste and recycling system:
 - Promote sustainability of the solid waste and recycling system that includes maximum efficiency, equity and economic vitality, improved worker safety and reduced environmental and human health impacts over the entire life cycle of the materials, and
 - Minimize the impact of harmful wastes by targeting toxicity and reducing greenhouse gases emissions, and
 - Reduce per capita waste generation below 2005 levels by the year 2015, and maximize recovery of all waste with a target of 75% by the year 2015 and promote highest value use of the recovered materials.
3. As of July 2005, Solid Waste and Recycling Administrative Rules mandate that all recycling and garbage companies collect recyclables from multifamily complexes using a two-sort system.
4. Through continuing agreements with City of Portland, Portland State University (PSU) assists in the education, outreach and implementation of a standardized recycling system for multifamily complexes throughout Portland, per Exhibit 1.
5. For Fiscal Years 2014/15, 15/16 and 16/17 PSU will continue to provide recycling and waste prevention assistance to multifamily managers/owners and tenants.
6. PSU will provide monthly progress reports to the City and hold quarterly meetings with the City.
7. The established cost is \$135,000 for three years. Funds are available in the Solid Waste Management Fund, FY 14/15 Adopted Budget, Bureau of Planning and Sustainability, Cost Center PNSD 000004, Cost Object 9PNSWC000003. Funding for FY 15/16 and FY 16-17 will be appropriated in the 2015-16 and FY 2016-17 fiscal years.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute an intergovernmental agreement with PSU in a form substantially in accordance with the agreement attached and referenced as Exhibit 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Bureau of Planning and Sustainability, Cost Object 9PNSWC000003 when demand is presented and approved by the proper authority.
- c. The Director of the Bureau of Planning and Sustainability is hereby authorized to sign amendments for continuing data management, reporting and funding in future fiscal years if appropriations are approved by City Council.
