Authorize an Intergovernmental Agreement with Multnomah County for the use of U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance FY 2014 Edward Byrne Memorial Justice Assistance Grant Program funds (Ordinance)

2) Purpose of the Proposed Legislation:

The City of Portland, the City of Gresham and Multnomah County are disparate jurisdictions. The City will submit a joint application for the aggregate eligible allocation to all disparate municipalities. Intergovernmental Agreements with the City of Gresham and Multnomah County must be executed by and submitted to U.S. Department of Justice (USDOJ) along with the application documents prior to June 10, 2014.

d) Who designed and implemented the public involvement related to this Council item?


The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance dictated the application review requirements.
