Referred to Commissioner of Public Affairs

Direct the City Budget Office to establish an ongoing General Fund current appropriation level target of \$300,000 for the Housing Investment Fund, starting in FY 2015-16 to be adjusted in the Fall Budget Monitoring Process to reflect half of prior year collections of transient lodging taxes from short term rentals (Resolution)

WHERAS, Portland City Council is considering enacting new regulations that would legalize short term rentals in certain specific and defined circumstances; and

WHEREAS, the Transient Lodging Tax of twelve and a half percent (12.5%) collected in Multnomah County from the short term rentals would be expected to be collected and submitted to the City of Portland to be distributed in accordance with the current formula; and

WHEREAS, an amount that equals half of the City of Portland's five percent (5%) portion of the transient lodging tax for short term rentals shall be budgeted ongoing for the development or preservation of affordable housing in Portland or to help low-income individuals and families access affordable housing; and

WHEREAS, the funds budgeted for the Housing Investment Fund shall be used to support individuals and families earning sixty-percent (60%) or less than the median family income; and

WHEREAS, Portland is experiencing a deficiency in the number of available affordable rental units, the City of Portland currently has a rental vacancy rate of three percent (3%) which is one of the lowest in the nation, correlating to one of the tightest rental markets among metropolitan areas in the United States of America; and

WHEREAS, the legalization of more short term rentals in certain circumstances will potentially impact the availability of long term rental housing; and

NOW, THEREFORE, BE IT RESOLVED, that City Council directs the City Budget Office to establish an ongoing General Fund current appropriation level target of \$300,000 for the Housing Investment Fund, starting in FY 2015-16. The Portland Housing Bureau will use these funds for the development or preservation of affordable housing in Portland or to help low-income individuals and families access affordable housing.

BE IT FURTHER RESOLVED, that the City Budget Office will report to Council every year during the Fall Budget Monitoring Process on the prior year collections of transient lodging taxes from short term rentals and adjust the current appropriation level target to meet the Council intent of having half appropriated to the Housing Investment Fund.
