Acceptance of the grants will generate \$534,824 in Continuum of Care homeless assistance funds from the U.S. Department of Housing and Urban Development.

The HMIS grant requires a cash match of \$61,417. Funds for the match from non-City users are collected in the Housing Investment Fund. The OTIS grant requires a cash match of \$72,290. Funds for the match are provided by Cascadia and Transition Projects as a contractual obligation for their receipt of the subgranted funds. Appropriation authority for these grants is included in the FY 2013-14 Revised Budget, and in the Bureau's FY 2014-15 Requested Budget.

## a) What impacts are anticipated in the community from this proposed Council item?

As part of the 2011-2016 Consolidated Plan and 2013-2014 Action Plan, the City allocated \$10 million in federal housing and community development funds to its community partners to implement strategies to preserve and develop affordable housing; provide housing access and stabilization services to people experiencing homelessness and others facing barriers to housing; provide homeownership education and counseling programs to low- and moderate-income households, including foreclosure prevention; address housing health and safety concerns; and expand access to economic opportunity for low-income people.

The goal of preventing and ending homelessness is clearly documented in the 2013-2014 Action Plan. If awarded, the subrecipient contracts will provide resources to address the emergency and long-term housing and service needs of men, women and children experiencing homelessness in our community.

For this council item, the City of Portland anticipates the following benefits will result from contracted services: The OTIS program provides 33 units of permanent supportive housing to approximately 35 chronically homeless mentally ill individuals per year through subcontracted program delivery by Cascadia and Transition Projects; the continued operation of our community's Homeless Management Information System (HMIS) database, which is administered by PHB to provide client-level demographic and service utilization data for homeless services throughout Multnomah County. HMIS is essential to tracking community-wide outcomes and performance on our strategies and programs to end homelessness.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved? As required by federal regulations, a Citizen Participation Plan (CPP) describing the overall framework for public involvement was developed and adopted with the 2011-2016 Consolidated Plan.

A series of hearing and public meetings were held regarding the development of the Plan, in all areas of the city to ensure access to a broad range of community members. Translation services were provided when requested. All hearings locations were accessible to persons with disabilities. All documents were posted on the Portland Housing Bureau website.

As part of the Plan, the Portland Housing Advisory Commission (PHAC), the bureau's advisory body, reviewed the Plan and its recommendations. The Federal Funding Oversight Committee, a representative body of the three jurisdictions (Portland, Gresham, and Multnomah County) also reviewed the Plan.

c) How did public involvement shape the outcome of this Council item? In the Consolidated Plan process, public involvement affected the City's understanding of community needs to prevent and end homelessness. For this particular initiative, it emphasized: the continued shortage of permanent supportive housing and other affordable housing; the impact of the economic recession on very low-income households; demand for rent assistance; and the need to promote greater systems alignment of housing and services.

These needs, in turn, influenced the set of goals in PHB's 2011-13 Strategic Plan and budget decisions. Investment in preventing and ending homelessness efforts is reflected in two of the Strategic Plan's four investment priorities. PHB's Strategic Plan, an outcomes-driven framework guiding Portland's housing investments, synthesizes available data on trends, needs and program outcomes, as well as community input gathered from focus groups, surveys and the strategic plan community forum.

d) Who designed and implemented the public involvement related to this Council item?

The public involvement process used in the contracting of funds for Housing Access & Stabilization and Ending Homelessness Initiative programs is contained in the Citizen Participation Plan (CPP), within the 2011-2016 Consolidated Plan. The CPP was adopted by the former Housing and Community Development Commission, and reviewed by the new Portland Housing Advisory Commission. Implementation of the CPP is managed by public involvement staff of the Portland Housing Bureau.

#### I. RECOMMENDATION

That Council accept two grants from the US Department of Housing and Urban Development.

#### II. BACKGROUND

The Portland Housing Bureau (PHB) applied to the U.S. Department of Housing and Urban Development (HUD) for an annual renewal of two Continuum of Care grants in the total amount of \$534,824 for administration of the regional Homeless Management Information System (HMIS) and OTIS supportive housing programs on 1/31/2014. The grant for the administration of the regional HMIS is in the amount of \$245,666. HMIS is the community-wide data system required by HUD and administered by PHB to provide client-level demographic and service utilization data for homeless services throughout Multnomah County. The other grant is for continued implementation of the OTIS supportive housing program in the amount of \$289,158. Funds through this program are subcontracted to Cascadia Behavioral Healthcare and Transition Projects, who deliver the supportive housing services.

Data and analysis provided through the HMIS continually informs planning and evaluation of the region's 10-Year Plan to End Homelessness, PHB

budgets and contracted program outcomes. The OTIS program provides 33 units of permanent supportive housing to approximately 35 chronically homeless mentally ill individuals per year through subcontracted program delivery by Cascadia and Transition Projects. Innovative Housing partners will provide affordable rental units for program participants. Both programs require this annually renewable funding in order to operate.

HUD has subsequently renewed both grants to the City of Portland. This ordinance authorizes the Mayor to accept the grant renewals and execute associated grant agreements with HUD.

Acceptance of the grants will generate \$534,824 in Continuum of Care homeless assistance funds from the U.S. Department of Housing and Urban Development.
