**ORDINANCE No. 186635**

\*Authorize a contract with the lowest responsible bidder for the N Williams Traffic Safety and Operations Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The N Williams Traffic Safety and Operations Project will improve bicycle capacity and safety, pedestrian crossing safety, access to transit, and reduce traffic speeds along N Williams Ave between NE Broadway and NE Killingsworth St.
2. The project was developed through an extensive public involvement process that started in 2011 and supported by the project's 22 member Stakeholder Advisory Committee.
3. In 2012, the Portland Bureau of Transportation (PBOT) applied to the Oregon Department of Transportation (ODOT) for a Bicycle and Pedestrian Program grant in the amount of \$1,515,000 to design and construct the project.
4. Project design is completed and now PBOT is proceeding with bidding the project for construction.
5. The Bureau's level of confidence in the cost estimates for this project is moderate, as plans, specifications, and estimates are now completed and the project is ready for bidding.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to T00269 when demand is presented and approved by the proper authority.


