1) Legislation Title:

Authorize a temporary loan from the Parks Capital Improvement Fund to the Golf Fund to provide interim financing for the redesign of Colwood Golf Course. (Resolution)

2) Purpose of the Proposed Legislation:

A temporary loan is hereby authorized as needed from Parks Capital Improvement Fund to the Golf Fund in an amount not to exceed one million, five hundred thousand dollars (\$1,500,000) to re-develop the existing Colwood National Golf Course into a 9-hole, Par 3 golf course to generate revenue to offset the debt service and the purchase of the property itself.
