ORDINANCE No. 186649

* Amend fee schedule for the Office of Neighborhood Involvement Noise Control Program (Ordinance)

The City of Portland Ordains:

Section 1. The Council finds:

- 1. The Office of Neighborhood Involvement's Livability Programs provide tools and resources to improve community livability and safety. The Noise Control Program works to improve neighborhood livability by enforcing noise regulations and issuing variances for events and activities that cause more noise than normally allowed.
- 2. In Fiscal Year 2013-14 the Noise Control Program was transferred from the Bureau of Development Services (BDS) to the Office of Neighborhood Involvement (ONI). ONI adopted a fee schedule planned for Noise Control by BDS and used BDS' existing administrative review and appeal fees to maintain consistency during the transition.
- 3. The fees charged by the Office of Neighborhood Involvement partially fund the Noise Control Program but are not intended to provide full cost recovery for the critical service of enforcing Title 18 Noise Regulations.
- 4. The fees provided in Exhibit A include a 5% increase to the Noise Variance fees, and adds the relevant Additional Fees charged previously under a Memorandum of Understanding using BDS' Enforcement Fee and Penalty Schedule.
- 5. The Office of Neighborhood Involvement has reduced the Administrative Review Appeal Fee significantly. Although the proposed fee does not provide recovery of the direct costs related to taking a case to Code Hearings, it is proposed at a level intended to be more manageable for appropriate appeals.
- 6. The Noise Review Board, which is composed of community and industry representatives, reviewed and supported the fee changes referenced in this ordinance.
- 7. The changes to the fees provided in Exhibit A are required to reach the budgetary goals for Fiscal Year 2014-15.

NOW, THEREFORE, the Council directs:

- a. The Fee Schedule attached as Exhibit A to this ordinance shall be effective July 1, 2014.
- b. Exhibit A to this ordinance is adopted as binding City policy.

Section 2. The Council declares that an emergency exists because the fees should be in place to meet budgetary goals for Fiscal Year 2014-15; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
