1) Legislation Title: *Amend contract with TriMet for Design and Construction Management Services for the Portland-Milwaukie Light Rail Project (Ordinance; amend Contract No. 30001514)

2) Purpose of the Proposed Legislation: City-requested betterments that were previously added to the project now have final costs. There are also additional City requests for other betterments to be paid with City funds to be added to the project, along with establishment of a permit fee fund. This third amendment to the IGA captures adjustments to betterments and increased compensation for services provided to TriMet.

Total revenue to be received by City for increased permit-related services by PBOT totals \$277,000. This increases PBOT's share from \$7.5M to \$7.8M.

Betterments requested by the City to be constructed with the light rail project are paid for by each bureau requesting the addition. Increased and new betterment totals per bureau are: BES - \$4,370,907; PWB - \$804,865; PBOT - \$364,602. Funding sources and year of payment for each betterment varies by bureau. For PBOT, betterments are paid by: arterial performance project (\$1,715); SW Moody project (\$12,108); Innovation Quadrant TSDC (\$284,762) per ordinance 185580; contract paving (\$66,017). In addition to betterments, BES is also paying some other City project costs totaling \$41,174.
