

ORDINANCE No. 186657

Authorize an open and competitive solicitation process for residuals hauling services to Madison Ranches for a contract in an estimated annual amount of \$1,500,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Approves competitive solicitation process of a 5 year contract with a 5 year renewal option for residuals hauling services to Madison Ranches.
2. The established cost is \$1,500,000 annual estimated cost. Funds are available in the Sewer System Operating Fund, FY 2014 Budget, Bureau of Environmental Services, Cost Center = ESWW000007

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to execute a contract with the successful bidder for the purpose described in Section 1, in the amount of \$1,500,000 annual estimated amount.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


