*Extend contract with Infor Public Sector, Inc., formerly Hansen Information Technologies, to extend the term to provide five more years of software maintenance and support for an amount not to exceed \$560,000 (Ordinance; amend Contract No. 31000031)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On June 1, 2009, the City executed contract No. 31000031 with Hansen Information Technologies for maintenance and support of the Hansen software used by the Bureau of Environmental Services (BES) to manage sewer and storm water linear assets.
- 2. The City has a perpetual license for use of the Hansen software under Contract No. 31000030 executed with Hansen Information Technologies.
- 3. The City seeks to renew the maintenance and support contract for an additional five years in order to ensure continuity of support and upgrades for the Hansen software.
- 4. Funds for the first year of the extension are available in the Sewer System Operating Fund, FY2014-15 Budget, Bureau of Environmental Services, Cost Center ESBS000005. Funding for the additional years of the extension will be requested in future annual budget processes.
- 5. This amendment will increase the contract by \$560,000. The contractual total will be \$1,036,092.06

NOW, THEREFORE, the Council directs:

a. The City's Chief Procurement Officer is hereby authorized to execute a contract amendment in a form substantially in accordance with the attached Exhibit A, to extend the term of the contact for five years and add \$560,000.00, resulting in a total not-to-exceed value of \$1,036,092.06.

Section 2. The Council declares that an emergency exists because the City needs to act promptly in order to secure the discounted price and ensure uninterrupted support for the software. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


