TO THE COUNCIL:

The Chief Procurement Officer has advertised and received bids for Bid Number 116653 for the SE 136th Ave: SE Foster – SE Holgate Blvd Sidewalk Infill Project for the Bureau of Transportation, with a project construction estimate of \$1,600,000.00. The Bureau of Transportation rated the project estimate confidence level as Moderate.

Bids were opened on April 29, 2014, and three (3) bids were received. The low bid of Brown Contracting, Inc. was deemed responsive to the requirements of the solicitation, and it is recommended that their bid be accepted at the unit price quoted in their bid for a total estimated amount of \$1,336,320.00.

The Bureau of Transportation along with Procurement Services, identified twelve (12) Divisions of Work as potential M/W/ESB subcontracting opportunities for this project, resulting in \$241,609.00 awarded to subcontractors.

The Divisions of Work identified were:

In their bid Brown Contracting, Inc. indicated their intent to self-perform the following divisions of work:

MWESB participation represents 26.2% or \$63,075.00 of the estimated subcontracting dollars.

MBE - \$ 63,075.00 performing Traffic Control Services (Includes TPDT)

Brown Contracting, Inc. has a current City of Portland Business Tax Registration and their EEO Certification is current through October 14, 2015. The company is located in Eugene, Oregon, and is not a State Certified M/W/ESB Contractor.

Brown Contracting, Inc. is in Full Compliance with the Equal Benefits Program.

Funds are available in the FY 2014 Budget, Bureau of Transportation, WBS Element T00395.

It is further recommended that a Performance Bond and a Payment Bond each in the amount of 100% of the contract amount be furnished by the Contractor.

It is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final contract amount be furnished by the Contractor before final payment is released.

The bid sureties of the remaining bidders should be returned immediately in compliance with Section 5.34.410D of the City Code.
