ORDINANCE No. 186679

Authorize grant agreement with Southwest Neighborhoods Inc. to provide outreach, technical assistance and community involvement for watershed projects in Fanno and Willamette watersheds up to \$73,000 for FY 2014/15 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On March 8, 2006, the Council adopted the 2005 Portland Watershed Management Plan (PWMP), which describes actions for watershed health including citizen led activities such as stormwater management, revegetation, education, and stewardship.
- 2. Much of the success of the PWMP relies on the extent of citizen and community participation. Southwest Neighborhoods Inc. is a neighborhood coalition which provides information, education and technical assistance to residents in SW Portland.
- 3. The Bureau of Environmental Services (BES) has been successfully partnering with SWNI since 1999 to provide watershed education at the SW Watershed Resource Center, and since 2001 to involve citizens in watershed project implementation.
- 4. The established cost is \$73,000 and is available in the Sewer System Operating Fund, FY 2014/15 Budget, Bureau of Environmental Services; Cost Objects ESWS000009 (\$36,500), ESWS000006 (\$36,500).

NOW, THEREFORE, the Council directs:

- The Director of the Bureau of Environmental Services is authorized to execute a a. grant agreement with SWNI for the purpose described in Section 1, in the amount of \$73,000.
- b. The Director of the Bureau of Environmental Services is authorized to execute amendments to this grant agreement that do not increase the grant amount.
- The Mayor and Auditor are hereby authorized to draw and deliver warrants C. chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
