Multnomah County, the City of Gresham and the City of Portland desire to enter into agreements to provide financial support to Portland for taking lead responsibility for coordination of the inter-jurisdictional 2011-2016 Consortium Consolidated Plan updates and one-year Action Plans 2015-16, as well as other plans and performance reports as requested of the Consortium by HUD during FY 2014-2015.

Multnomah County and the City of Gresham have agreed to reimburse PHB \$3,400 and \$10,000, respectively in CBDG for FY 2014-2015 for coordination of the 2011-2016 Consolidated Plan Amendments, updated Analysis of Impediments Action Plan, and Action Plans FY 2015-2016. These amounts were included in PHB's FY 2014-15 base budgets.


