ORDINANCE No. 186682

Amend a grant agreement with YWCA of Greater Portland for navigator services at the Gateway Center for Domestic Violence Services (Ordinance; amend Contract No. 32000375)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Pursuant to an invitation to Submit a Request for Grant circulated publicly on or about April 15, 2010, City sought to provide grants to fund domestic violence victim-centered and culturally specific navigator/ advocacy services on site at the Gateway Center for Domestic Violence Services ("the Center"), located at 10305 E. Burnside Street, in Portland, Oregon.
- 2. Portland City Council, through City Ordinance No. 183792, authorized a grant agreement with Grantee after Grantee was selected for grant award based on its response to the invitation.
- 3. The resulting Grant Agreement No. 32000375 was executed on or about June 1, 2010. The term of the Grant Agreement was June 1, 2010 to May 31, 2013.
- 4. In 2013, the Portland City Council, through City Ordinance No. 185321, amended the original agreement and extended its term to June 30, 2014.
- 5. The Center has operational funds to extend the payment for navigator services provided by the YWCA until June 30, 2015.
- 6. There has been no increase in funding since 2010. This amendment provides a 5% increase in funding for these services.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is authorized to sign the grant amendment with the YWCA in substantial conformance with the one attached as Exhibit A and approved as to form by the City Attorney.
- b. The grant funding for navigator services in an amount not to exceed \$56,700 will be from the Center's ongoing operations budget.
