## ORDINANCE No. 186683

Amend a grant agreement with Catholic Charities El Programma Hispano for navigation services specifically for Latina populations at the Gateway Center for Domestic Violence Services (Ordinance; amend Contract No. 32000391)

The City of Portland ordains:
Section 1. The Council finds:

1. Pursuant to the Invitation to Submit a Request for Grant circulated publicly on or about April 15, 2010, City sought to provide grants to fund domestic violence victim-centered and culturally specific navigator/ advocacy services on site at the Gateway Center for Domestic Violence Services ("the Center"), located at 10305 E. Burnside Street, in Portland, Oregon.
2. Portland City Council, through City Ordinance No. 183785, authorized a grant agreement with Grantee after Grantee was selected for grant award based on its response to an invitation to provide Latina-specific navigator/ advocacy services at the Gateway Center for Domestic Violence Services.
3. The resulting Grant Agreement No. 32000391 was executed on or about June 1, 2010. The effective date of the Grant Agreement was June 1, 2010 to May 31, 2013.
4. Portland City Council, through City Ordinance No. 185323, amended the original grant agreement, to extend funding for navigator services through June 30, 2014, and client assistance monies through June 30, 2015.
5. The Gateway Center has additional available funds for navigator services. Catholic Charities was originally granted an additional $\$ 2000$ annually based on an expectation that the Catholic Charities navigator would have a lead role in administering client assistance funds. That lead role did not actualize. Therefore, this amendment reduces the original funding by the $\$ 2000$, and then increases the remainder by $5 \%$.

NOW, THEREFORE, the Council directs:
a. The Commissioner of Public Affairs is authorized to sign the grant amendment with Charities El Programma Hispano in substantial conformance with the one attached as Exhibit A and approved as to form by the City Attorney.
b. The grant funding for navigator services in an amount not to exceed $\$ 56,700$ will be from the Center's ongoing operations budget.
