## RECITALS:

- A. Pursuant to the Invitation to Submit a Request for Grant circulated publicly on or about April 15, 2010, City sought to provide grants to fund domestic violence victim-centered and culturally specific navigator/ advocacy services on site at the Gateway Center for Domestic Violence Services ("the Center"), located at 10305 E. Burnside Street, in Portland, Oregon.
- B. Portland City Council, through City Ordinance No. 183785, authorized a grant agreement with Grantee after Grantee was selected for grant award based on its response to an invitation to provide Latina-specific navigator/ advocacy services at the Gateway Center for Domestic Violence Services.
- C. The resulting Grant Agreement No. 32000391 was executed on or about June 1, 2010. The effective date of the Grant Agreement was June 1, 2010 to May 31, 2013.
- D. Portland City Council, through City Ordinance No. 185323, amended the original grant agreement, to extend funding for navigator services through June 30, 2014, and client assistance monies through June 30, 2015.
- E. The Gateway Center has additional available funds for navigator services. Catholic Charities was originally granted an additional \$2000 annually based on an expectation that the Catholic Charities navigator would have a lead role in administering client assistance funds. That lead role did not actualize. Therefore, this amendment reduces the original funding by the \$2000, and then increases the remainder by 5%.

Therefore, the Parties agree as follows:

- 1. The Recitals above are true and correct and are part of this Amendment No. 2.
- 2. The Grant Agreement term regarding navigator services shall extend and additional year ("Additional Service Year") and shall terminate on June 30, 2015, unless otherwise sooner terminated under any provisions of the Grant Agreement.
- 3. The total grant funds shall be increased by \$56,700 ("Additional Funds") to reflect the additional funding indicated in the above Recitals.
- 4. Except as modified in Amendment No. 1, and this Amendment No. 2, the terms and
