ORDINANCE No. 186684

Amend a grant agreement with the Immigrant and Refugee Community Organization for navigation services specifically for Immigrant and Refugee populations at the Gateway Center for Domestic Violence Services (Ordinance; amend Contract No. 32000976)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Portland City Council, through City Ordinance No. 186121, authorized a grant agreement with Grantee after Grantee was selected for grant award based on its response to an invitation.
- 2. The resulting Grant Agreement No. 32000976 was executed on or about July 1, 2013. The effective date of the Grant Agreement was July 1, 2013 to June 30, 2014.
- 3. IRCO has provided excellent advocacy services under the terms of the agreement. The Gateway Center participants benefit from having services specifically for immigrant and refugee communities.
- 4. The Center has operational funds to extend the payment for navigator services provided by IRCO until June 30, 2015.
- 5. The current agreement followed an earlier agreement which began in 2010. There has been no increase in funding since 2010. This amendment provides a 5% increase in funding for the services.

NOW, THEREFORE, the Council directs:

- The Commissioner of Public Affairs is authorized to sign the grant a. amendment with the Immigrant and Refugee Community Organization in substantial conformance with the one attached as Exhibit A and approved as to form by the City Attorney.
- b. The grant funding for navigator services in an amount not to exceed \$28,400 will be from the Center's ongoing operations budget.
