a) What impacts are anticipated in the community from this proposed Council item?

This sewer construction project will replace or repair about 7,000 feet of public sewer pipes in the Kenton neighborhood that are between 80 and 90 years old and failing due to age. Replacing and repairing these sewer pipes will help protect the public and the environment by reducing the possibility of costly breaks, leaks, blockages and sewage releases to homes, businesses and streets. Both open trench and cured-in-place-pipe lining (CIPP) construction methods will be used. The most significant issues will most likely relate to individual impacts at properties as well as disruption to traffic and business access along NE Denver, Kenton's main street, between Kenton and Willis. Construction will create noise, vibration and dust and will disrupt normal neighborhood activity. Cured in-place-pipe lining produces a temporary odor; while unpleasant, it is not harmful to human health. Traffic control signs will be set up. The contractor will maintain local access, but delays should be expected. On-street parking in or near the work area will be prohibited during construction hours. Equipment and materials may be stored on nearby streets overnight.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

The construction contracting community, including contractors certified with the State of Oregon as minority, women, and emerging small businesses. They became involved when the project advertised for bids on April 30, 2014.

c) How did public involvement shape the outcome of this Council item?

Bids received resulted in the award of the construction contract.

d) Who designed and implemented the public involvement related to this Council item?

Procurement Services advertised the project for bids and held the prebid meeting that was open to the construction contracting community, including contractors certified with the State as minority, women, and emerging small businesses.



7. **BACKGROUND/ANALYSIS:** Ordinance Number 186496 adopted March 19, 2014 authorized a contract and provided for payment for the Kenton Sewer Rehabilitation. The Kenton Sewer Rehabilitation project involves the construction approximately 7,000 feet of combined and sanitary sewer pipe is to be replaced or rehabilitated in the Kenton neighborhood between N Argyle St, N Lombard St, I-5 Fwy and N Delaware Ave. These pipes are in severely deteriorated condition and need to be replaced or rehabilitated.
8. **FINANCIAL IMPACT:** The engineer's estimate for this project was \$2,550,000 and the confidence level was High. Funds are available in the Sewer System Operating Fund, FY 2014, 2015 & 2016 Budgets, Bureau of Environmental Services, WBS Element E10357.
9. **RECOMMENDATION/ACTION REQUESTED:** Accept Recommendation to award contract to Emery & Sons Construction, Inc. in the amount of \$2,626,500.00.
10. **SCOPE OF WORK ON PROJECT:** The project includes all labor, materials, tools, equipment, and supervision necessary to replace or rehabilitate approximately 7,000 feet of combined and sanitary sewer pipe, inlets and manholes in the Kenton Neighborhood.
