# **Garden** – Gretchen Sperling

A chairperson for the Garden would be most welcome. The ENA is responsible for one hundred percent of the maintenance of the Garden.

#### Railroad – Richard Pierce

The history of the litigation between the ENA and the railroad was discussed. Mr. Pierce has met with Union Pacific several times and enforcement of the agreed upon limits to coupling and uncoupling of trains is exceedingly difficult. Most of the recent neighborhood complaints involve train horns rather than coupling and uncoupling noises.

#### **Land Use** – Kathy Ten Pas

Remodeling has slowed down in the neighborhood, likely due to the economy. Ms. Ten Pas receives notice from the city when a homeowner requests a variance from city code. Sidewalks are inspected by the city on a twenty five to thirty year cycle. Inspections may occur sooner if the city receives a complaint about a sidewalk.

There was discussion about homeowner encroachment on public property. Portland Department of Transportation would be the agency to contact with questions about this.

## Transportation – Jerry Curtis (?), Dan Packard

There will be a Light Rail stop at the Bybee overpass. There are many issues that need to be addressed including parking and crosswalks. There will be access to the station on both sides of Bybee. Please contact Mr. Packard with questions.

Safety issues were discussed. TriMet says that there are 0.65 crimes per 100,000 riders on TriMet.

## **Remodeling Fair** – Kurt Krause

The Remodeling Fair is being postponed until 2010. Mr. Krause is doing personal research into house painters.

## Reed College Place Restoration Committee – Robert McCullough

The committee has been talking with Carol Mayer-Reed, a landscape architect, regarding a plan of care for the Reed College Place strip. She has offered to do this work for \$6,800. The source of the funding for this is undetermined.

#### **New Business**

Peggy McLean raised questions about the increase in crime in the neighborhood and the decrease in funding for the District Attorney's office. She would like to encourage concerned neighbors to contact the city to protest this funding cut. Mr. Ten Pas moved to have the ENA write a letter to Ted Wheeler, City Commissioner, regarding this. This motion was seconded and passed unanimously. Ms. McLean will draft this letter and bring it to the Executive Committee for approval.
