Dear Mayor:

I have sent you several emails regarding Megan McCoy describing how her felony sexual assault complaints have been investigated by the Portland Police Bureau. However, I did not receive a reply to any of the emails that I sent to you. So I would like to receive the opportunity to make citizen comments at the next available Portland City Council meeting.

The Portland Police Bureau received my client's criminal complaint from the Washington County Sheriff's Office more than two (2) years ago (specifically in January 2012). Thereafter my client and her advocate made several contacts with the PPB regarding the status of Megan's criminal complaint but were stonewalled. Because she was ignored Megan gave up. I met her several months ago and on her behalf notified PPB of their failure to investigate. Subsequently PPB notified me that they would conduct a thorough investigation but that has not happened. No one in the City of Portland has been willing to provide us a candid statement describing why my client's criminal complaint has been given short shrift.

So I want to come before the Council and explain to the members our profound concerns regarding PPB's actions and how they have caused my client extreme distress.

I anticipate that I will receive a prompt reply with a date for me to appear in person at the earliest possible time.
