This is an ongoing citizen-volunteer appointment to the Plumbing Code Board of Appeal. It will assist the community by maintaining the ability to appeal internal plumbing code decisions to an outside appeal board.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

There has been active on-going recruitment for an alternate member of the Plumbing Appeal Board. Current Board members notified their constituent groups of the vacant positions, and BDS included information about the vacancy in multiple issues of its *Plans Examiner* newsletter. The *Plans Examiner* is widely distributed electronically to BDS customers and stakeholders, as well as neighborhood associations and community groups. A link to the Plans Examiner is available on the BDS website. An interested applicant files an application of Interest with the Office of Neighborhood Involvement (ONI). Once ONI receives the applications and conflict of interest forms, it forwards those documents to Terry Whitehill in BDS for review.

Reappointments and Appointment to the Plumbing Code Board of Appeal

## Reappointment and Appointment Recommendations

The current Plumbing Code Board of Appeal terms have expired. Portland City Code 25.07.010 requires that the Plumbing Board of Appeal have three members appointed by the Mayor. One member must be a plumbing contractor with knowledge regarding the safety aspects of plumbing installations; one member must be a plumbing design expert; and one member must be from the public at large. There must also be an alternate member appointed for each of the categories.

The current members are: Steve Houston (plumbing contractor), Gary Toole (plumbing design member), and Roy Moore (public-at-large member). There are also currently two alternates on the Plumbing Board, Dale Lovett (plumbing contractor) and Jon Gray (plumbing design member). All of these individuals have proven to be valuable contributors to the Board and its work during their tenures.

Gary Toole has decided not to renew his membership on the board. I am recommending that Jon Gray be reappointed and moved from alternate to the Plumbing Design member of the board. I am also recommending that **Steve Houston** and Roy Moore be reappointed to their current positions, Plumbing Contractor and Public-at-large Member, respectively. Their partial 3-year terms would be from July 23. 2014 and expire December 31, 2016.

Attached is an application from **Victoria Havnes** (Public-at-large alternate). We are recommending that she be appointed as an alternate to the board. We are also recommending that Dale Lovett (Plumbing Contractor alternate) be reappointed as an alternate member. Their partial 3-year terms would be from July 23, 2014 and expire June 7, 2017.

These proposed reappointments and the appointment of Victoria Haynes will help ensure the continuation of the good work of the Appeal Board and leave one vacancy of an alternate with Plumbing Design expertise on the Appeal Board. We are continuing our outreach efforts to fill this vacant position. I have attached an updated Plumbing Code Board of Appeal membership list for your records.

## Plumbing Code Board of Appeal:

The Plumbing Code Board of Appeal consists of three members appointed by the Mayor. One member shall be a plumbing contractor whose experience and training qualify him to decide matters concerning the safety of installations and devices regulated by PCC Title 25; one member shall be a person engaged in the design of plumbing installations whose experience and training qualify him to decide matters concerning the safety of installations and devices and one member who shall be a member of the public at large. Appointments are made for 3 year terms. Code Board of Appeals hears appeals of plumbing code issues which are appealed beyond the Administrative Appeals Board. The Appeals Board may affirm annul or modify the action of BDS on the condition that substantially equivalent safety is provided generally conforming to national standards concerning fire prevention, fire safety measures, and building construction requirements for safety.

This board meets as appeals are received.
