

ORDINANCE No. 18 6739

*Accept and appropriate a grant in the amount of \$47,189 from the State of Oregon, Youth Development Council for the Gang Impacted Family Team Coordinator (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. The Office of Youth Violence Prevention applied to the Oregon Department of Education for a grant in the amount of \$47,188.80 for the Gang Impacted Family Team Coordinator on March 8th, 2013, and received the award.
2. The Office of Youth Violence Prevention has now been granted an extension of the grant on July 22, 2014; and
3. The Youth Development Council has notified the City of Portland that it will award a grant for the Gang Impacted Family Team Coordinator to the Office of Youth Violence Prevention for an additional amount of \$47,188.80;
4. The State of Oregon, Youth Development Council grant requires matching funds, which the Office of Youth Violence Prevention has made available in its FY 2014-15 Adopted Budget.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the State of Oregon, acting by and through its Department of Education's Youth Development Council, for the Gang Impacted Family Team Coordinator position in the amount of \$47,188.80. The Mayor is authorized to execute an agreement with the State of Oregon, acting by and through its Department of Education's Youth Development Council, that substantially conforms to the agreement attached as Exhibit A.
- b. The FY 2014-15 budget is hereby amended as follows:

GRANTS FUND

Fund 217

Business Area – MY00

Bureau Program Expenses– \$47,188.80

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

- d. The Mayor of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by the Youth Development Council for Title II Formula Grant, CFDA #16.540, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
