ORDINANCE No. 18 6743 As Amended

Authorize a grant to Portland Business Alliance for Downtown Marketing Initiative Holiday promotions for \$170,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

- 1. Since June 2009, the City has contracted with Travel Portland for the purpose of promoting and leveraging marketing of the downtown area through the Downtown Marketing Initiative; and
- 2. The Council has expressed commitment to continue the holiday promotional portion of this initiative, which includes advertising, event, and promotional materials; information on clean, safe, and affordable parking available at City owned garages; and the continuation of the Ugly Sweater Yarnbombing project; and
- 3. Due to the staffing needs of Travel Portland, the Portland Business Alliance has offered to take on the oversight of the Downtown Marking Initiative Holiday promotions and waive their administrative costs; and
- 4. In order to meet the Downtown Marking Initiative Holiday costs for the 2014 holiday season, a one-time appropriation of \$170,000 will be necessary;

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute a grant agreement with Portland Business Alliance in a form that substantially conforms to the agreement attached as Exhibit A in an amount not to exceed \$170,000.
- b. The City Budget Office to appropriate \$170,000 from General Fund contingency to Special Appropriations in the FY 2014-15 Fall Budget Monitoring Process to provide holiday promotional services through the Downtown Marketing Initiative.
- c. The Mayor and the Auditor are hereby authorized to provide payment in the amount of \$170,000, chargeable to the applicable budgets when demand is presented and approved by the appropriate authorities.
