* Accept a grant in the amount of \$483,619 and appropriate \$360,000 for FY 2014-15 from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance FY14 Edward Byrne Memorial Justice Assistance Grant Program to prevent or reduce crime and violence (Ordinance)

2) Purpose of the Proposed Legislation:

The City wishes to accept a grant from the U.S. Department of Justice (USDOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) for the FY14 Edward Byrne Memorial Justice Assistance Grant Program on behalf of the jurisdictions certified as disparate - the City of Portland, Multnomah County and the City of Gresham. The grant period is October 1, 2013, through September 30, 2017.

The USDOJ will reimburse the City up to \$483,619 for approved program expenses. Multnomah County will receive \$185,076, the City of Gresham will receive \$62,995 and the City of Portland will receive \$235,548. The Police Bureau will extend the current LifeWorks NW New Options for Women contract with an additional \$110,000 in funding and retain a 1.0 FTE Senior Management Analyst for approximately 15 months.

There is no match requirement.

Application Review

The Portland Police Bureau posted a notice about the Edward Byrne Memorial Justice Assistance Grant (JAG) Program FY 2014 Local Solicitation on the City of Portland Police Bureau website <http://www.portlandonline.com/police/> on April 25, 2014, and its proposed joint application on May 23, 2014. Visitors to the site were able to view a description of the grant program, a link to the Office of Justice Programs solicitations web page as well as the application.
