This project involves the improvements of a limited access road in the Bull Run Watershed. All work performed in the Bull Run Watershed will not impact the public; there will be no impact to water delivery service or traffic impacts noticeable to the general public. This project has been included in budgeting documents which have been reviewed by the public; however no outreach has been made to the general public regarding this project. Updates to the project have been posted on the Quarterly Update project matrix available to the public through the Water Bureau website. There are no decisions on this project that require public involvement.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

The construction contracting community, including contractors certified with the State of Oregon as minority, women, and emerging small businesses. They became involved when the project advertised for bids on July 7, 2014.

Bids received resulted in the award of the construction contract.

Procurement Services publically solicited the project as a competitive invitation to bid on the OnLine Procurement Center and managed the procurement process. A pre-bid meeting was held and open to the construction contracting community, including contractors certified with the State as minority, women, and emerging small businesses.



7. **BACKGROUND/ANALYSIS:** Ordinance Number 186607 adopted May 28, 2014 authorized a contract and provided for payment for the Road 10 MP .6 – 1.8 project. The Water Bureau requires rehabilitation and improvement of the segment of Road 10 .6 – 1.8 which is the main road to the facilities in the Bull Run Watershed. The poor condition of the road requires reconstruction as it is beyond the effectiveness of preventative maintenance techniques. In addition, this section of road does not meet the design criteria adopted in the Transportation System Maintenance Plan for adequate width for safe use by heavy equipment and personnel; it has also experienced failures where it crosses several landslide zones.
8. **FINANCIAL IMPACT:** The engineer's estimate for this project was \$685,000.00 and the confidence level was Moderate. Funds are available in the FY 2014/2015 Budget, Portland Water Bureau, WBS Element W10670.
9. **RECOMMENDATION/ACTION REQUESTED:** Accept Recommendation to award contract to PCR, Inc. in the amount of \$736,837.00.
10. **SCOPE OF WORK ON PROJECT:** The Road 10 MP .6 – 1.8 project involves the construction of street improvements along Road 10 MP .6 – 1.8 located in the Bull Run Watershed.
