## **ORDINANCE No.** 186784

Extend term of a franchise granted to tw telecom of oregon llc to build and operate telecommunication facilities within City streets (Ordinance; amend Ordinance No. 171566)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On September 4, 1997, the Council granted a franchise to GST Telecom Oregon, Inc., ("GST") to build and operate telecommunications facilities within the City's streets. Ordinance No. 171566.
- 2. On April 10, 2002 the Council consented to a transfer of the GST franchise to Time Warner Telecom Oregon LLC. Ordinance No. 176377. Time Warner Telecom Oregon LLC subsequently changed its business name to tw telecom of oregon llc ("TW").
- 3. The Council has previously extend the term of the franchise ordinance. Most recently, in November, 2012, the Council extended the term of the TW franchise until December 31, 2014. Ordinance No. 185746.
- 4. TW has indicated to the Office for Community Technology that TW wants to continue to use City streets for its telecommunications facilities, and to obtain permits to perform work in the City streets. City staff is negotiating a renewal agreement, including revised standardized franchise language. Although franchise negotiations for a renewal agreement are in progress, the parties have not reached agreement on all terms. City staff recommends that the Council extend the existing franchise to allow time for parties to complete negotiations for a new agreement and to formally complete the Portland City Charter procedure for proposed franchises, which can take up to four months or more from the date of the required initial publication.

NOW, THEREFORE, the Council directs:

- a. Ordinance Number 171566 is hereby amended to extend the term of the franchise, continuously and without interruption, through December 31, 2016.
- b. All other terms and conditions of the franchise shall remain the same.

c. On or before the thirtieth (30th) day after this ordinance becomes effective, tw telecom of oregon llc shall file in the Office of the Auditor of the City of Portland a written acceptance of this ordinance, executed by tw telecom of oregon llc , meeting the approval of the City Attorney. Any failure on the part of tw telecom of oregon llc to file such written acceptance within such time shall be deemed an abandonment and rejection of this ordinance, and this ordinance shall thereupon be null and void. Such acceptance shall be unqualified and shall be construed to be an acceptance of all the terms contained in this ordinance.


