

ORDINANCE No. 18 6785

Extend term of a franchise granted to McLeodUSA Telecommunications Services, Inc. to build and operate telecommunication facilities within City streets (Ordinance; amend Ordinance No. 175061)

The City of Portland ordains:

Section 1. The Council finds:

1. In November 2000, the Council granted a ten year franchise to McLeodUSA Telecommunications Services, Inc., an Iowa corporation qualified to do business in Oregon, and to its successors and assigns, as approved by the City ("McLeodUSA"), to use the City streets to provide telecommunications services. Ordinance No. 175061. McLeodUSA filed an acceptance of the franchise grant in November, 2000.
2. The Council has previously extended the term of the franchise ordinance. Most recently, in November, 2012, the Council extended the term of the McLeodUSA franchise until December 31, 2014. Ordinance No. 185748.
3. City staff is negotiating a renewal agreement, including revised standardized franchise language. Although franchise negotiations for a renewal agreement are in progress, the parties have not reached agreement on all terms. City staff recommends that the Council extend the existing franchise to allow time for parties to complete negotiations for a new agreement and to formally complete the Portland City Charter procedure for proposed franchises, which can take up to four months or more from the date of the required initial publication.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 175061 is amended to extend the term of the franchise, continuously and without interruption, through December 31, 2016.
- b. All other terms and conditions of the franchise shall remain the same and unchanged.

- c. On or before the thirtieth (30th) day after this ordinance becomes effective, McLeodUSA Telecommunications Services, Inc. shall file in the Office of the Auditor of the City of Portland a written acceptance of this ordinance, executed by McLeodUSA Telecommunications Services, Inc. meeting the approval of the City Attorney. Any failure on the part of McLeodUSA Telecommunications Services, Inc. to file such written acceptance within such time shall be deemed an abandonment and rejection of this ordinance. Such acceptance shall be unqualified and shall be construed to be an acceptance of all the terms contained in this ordinance.
