

ORDINANCE No. 18 67 88

Accept a donation of a cargo trailer from the Shirlee Ann Foundation. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Shirlee Ann Foundation donated a small (3' x 4') cargo trailer to Portland Fire & Rescue (PF&R) that can be towed by the All-Terrain Vehicles (ATV) to transport patients and equipment in and around the St. Johns area.
2. The approximate value of the donation is \$547.
3. The Fire Chief recommends that the Council accept the donation from the Shirlee Ann Foundation.

NOW, THEREFORE, the Council directs:

- a. The City Council accepts the donation a small (3' x 4') cargo trailer to PF&R, and thanks the Shirlee Ann Foundation for its donation.


