## **ORDINANCE No.** 186791

\*Authorize a sponsorship agreement with SJW Inc. for De La Salle North Catholic High School work/study internship program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Providing internship opportunities for youth opens up career opportunities. Internship opportunities provide students with transformational experiences in an environment that cultivates personal and professional growth. The opportunity provides a positive impact on the lives of young people. The program will provide the students with tools and experiences that will help them in their educational and career pursuits.
- 2. De La Salle North Catholic High School provides a rigorous college preparatory education and is racially and culturally diverse. The internship program through De La Salle provides students, with few educational options and from families with limited economic means, a way to receive a college preparatory education.
- 3. Portland Parks & Recreation regularly sponsors interns from a variety of schools and organizations. Partnering with a school such as De La Salle will expand Portland Parks & Recreation's traditional internship opportunities.
- 4. De La Salle will provide Parks with four interns who will share one work study internship position during the school year. The established cost of this internship is \$27,295 for fiscal year 2014/15.

## NOW, THEREFORE, The Council Directs:

- a. The Director of PP&R is authorized to execute an agreement with De La Salle North Catholic High School, in substantially the same form as Exhibit A attached herein and as approved as to form by the City Attorney.
- b. The Director of Portland Parks and Recreation is authorized to provide payment in the amount of \$27,295, chargeable to the applicable budgets when demand is presented and approved by the appropriate authorities.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the commencement of the services to be provided by De La Salle; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.


