a) What impacts are anticipated in the community from this proposed Council item?

The community supports this work and anticipates positive impacts such as using information from the genetics work and ongoing monitoring work to further their efforts to raise awareness and engage residents in the stewardship of the Tryon Creek Watershed. Tryon Creek Watershed Council, the Oregon Parks and Recreation District and the Friends of Tryon Creek partner to restore the watershed and are currently working on replacing two culverts in the Lake Oswego part of the watershed for better fish passage.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

The Tryon Creek Watershed Council (TCWC) is the primary partner on the fish monitoring program. The City has had a representative on TCWC since its beginning in 1995. Though TCWC, the City works with council members which include governmental organizations (City of Lake Oswego, Multnomah Soil and Water Conservation District, Oregon Parks and Recreation District and other City bureau's such as Portland Parks), other organizations such as Lewis and Clark College, the Friends of Tryon Creek State Park, and neighborhood associations and individual council members.

The TCWC involves the community by providing volunteer opportunities for people to help with both the fish monitoring and other water quality monitoring efforts. TCWC makes the information gathered in these studies available to their constituents by hosting presentations and publishing information on their website <u>http://tcwc.tryonfriends.org/</u>

c) How did public involvement shape the outcome of this Council item?

BES is looking to extend the monitoring program and learn about fish genetics in part due to the interest and associated projects spearheaded by the TCWC.
