

ORDINANCE No. 186808

Authorize contracts with Brown and Caldwell, Inc., Kennedy/Jenks Consultants, Inc. and Murray, Smith & Associates, Inc. for professional engineering services to continue the Sewer System Rehabilitation Program: Project No. E10031, Phase 2 Pipe Rehabilitation; E10500, Phase 3 Pipe Rehabilitation; and E10576, Large Diameter Sewer Rehabilitation; for a total of \$9,000,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) owns, operates and maintains more than 2,300 miles of pipe, 96 wastewater pump stations and 2 wastewater treatment plants. Such a large system necessitates continuous programmatic evaluation, repair and improvement of facilities.
2. BES has identified a series of needs for structural rehabilitation of critical combined and sanitary sewers that are at the end of their economic life and have the highest consequence of failure.
3. The attached Agreements for Services are for the necessary work scope, costs, schedules and deliverables to provide design documents, bidding phase assistance and design support during construction for rehabilitation projects identified as part of Project No. E10031, Phase 2 Pipe Rehabilitation; E10500, Phase 3 Pipe Rehabilitation; and E10576, Large Diameter Sewer Rehabilitation.
4. The consultant selection has been conducted in accordance with Chapter 5.68 of the Code of the City of Portland (RFP No. BES150). The consultant selection committee recommended that contracts be awarded to three firms: Brown and Caldwell Inc., Kennedy/Jenks Consultants Inc., and Murray, Smith & Associates Inc.
5. The estimated cost for each contract is \$3,000,000, for a total cost of \$9,000,000 for a period of five years. The cost estimate level of confidence rating is optimal. Funds are available in the Sewer System Operating Fund, FY 2014-15 Budget, Bureau of Environmental Services, Cost Center ESEN000020, WBS Elements E10031.D14, E10500.D14, and E10576.P14.
6. M/W/ESB participation is estimated at 29.6% for Brown and Caldwell; at 42% for Kennedy/Jenks Consultants; and at 34% for Murray, Smith & Associates.

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute contracts with Brown and Caldwell Inc., Kennedy/Jenks Consultants Inc., and Murray, Smith & Associates Inc. for the purpose described in Section 1, in the amount of \$3,000,000 for each contract.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
