I spoke in April about getting the USS ZUmwalt here for the 2016 Rose Festival.

Alas, I almost got run over getting on a bus a few days ago, For some reason, there is a loading zone in front of a bus stop at 24th and NE Glisen (as pictured below) A company almost-always has its van in the zone, though I've never seen anything being loaded it in. Both the boarding rider's vision and that of the bus driver are limited, and we have to walk into the bike lane to get on the bus.

A few days ago, while on my way to a doctor, I could not see the bicyclist zooming right at me. It only diverted when the alert drive blew his horn, and the biker swerved. I've complained about this to Leah Treat's crew, as I've done before, but they're "studying it" I also complained to Tracy Reeve yet haven't heard a thing

As it's an accident waiting to happen -- and luckily I don't use a wheel chair -- and as this clearly violates the Americans With Disability Act I want to ask the council to immediately remove the loading zone.

Alternatively, I can file suit against the city in federal court, asking for a temporary restraining order, get a hearing within a day, and the city can explain to a federal judge why they've put a loading zone in front of a bus stop. I really like Portland. I do not want to sue. But what choice do I have?
