# 4) <u>Revenue</u>: Will this legislation generate or reduce current or future revenue coming to the City? If so, by how much? If so, please identify the source.

This project is funded through a Construction Excise Tax (CET) grant from Metro in the amount of \$380,759. An additional \$44,741 is being granted, bringing project total to \$425,500. The grant-funded activities are anticipated to span fiscal years 2013-14, 2014-15, and 2015-16.

The grant funds will be used to reimburse the Bureau of Planning and Sustainability (BPS) staff, material and services, and a consultant for the tasks listed in Exhibits A and B of the Intergovernmental Agreement (IGA).

# 5) <u>Expense</u>: What are the costs to the City as a result of this legislation? What is the source of funding for the expense?

Up to \$425,500 will be expensed to the Construction Excise Tax grant received from Metro. Local match in the amount of \$207,900 will be provided by funds from the Planning Program, (PNCP000001) for FY 2013-14, FY 2014-15, and FY 2015-16. The match will be in the form of salary, benefits, and materials and services in the FY 2013-14, FY 2014-15, and FY 2015-16 budgets of the Bureau of Planning and Sustainability.

BPS has assigned a currently employed Senior Planner to manage this project and has shifted a City Planner to the project team.

- 5. Purpose of Agenda Item: Authorize acceptance of additional Metro Construction Excise Tax (CET) grant for the Mixed Use Zoning Project; appropriation of additional \$44,741 in grant funds to develop new mixed use zoning framework to implement the Comprehensive Plan update. The grant total is \$425,500. Approval of the revised Intergovernmental Agreement (IGA) between the City of Portland and Metro. This item is designated an Emergency so that the City may continue work on the project.
- 6. History of Agenda Item/Background: Portland is expected to grow by over 100,000 households by 2035 and much of that growth is expected to be accommodated in a set of mixed use centers and corridors proposed throughout Portland in the Comprehensive Plan Update. The Mixed Use Zoning project is critical to implementation of the new Comprehensive Plan. The project will revise the city's mixed use zones in order to optimize them for development outcomes in different

- 7. What individuals or groups are or would be supportive or opposed to this action? BPS is aware of broad community support for this project and received multiple letters of support. Neighborhood interests anticipate a revised set of codes that may better respond to context and design issues in neighborhoods. Development and business interests have not expresseed concern but will be directly affected by the outcomes. City Bureaus, including BDS, will administer the new provisions and have an interest in creating a workable regulatory framework. Care will be taken to include perspectives and feedback from a variety of stakeholders. BPS is seeking project advisory committee members from various stakeholder groups in order to deliver a balanced product.
- 8. How does this relate to current City policies? This project directly responds to Portland Plan and the draft Comprehensive Plan Update policies that call for fostering a Healthy Connected City that is supported by a series of mixed use centers and corridors that will accommodate significant future population growth and serve as the focal point for commercial, retail and community services throughout Portland.
