- 7. **BACKGROUND/ANALYSIS:** The Retrofit Project involves the construction of sediment manholes, sumps and green street facilities within the right of way. The Underground Injection Controls (UIC) Category 3 Retrofit Project will bring the City's UICs into compliance with the permit issued by the Department of Environmental Equality (DEQ Permit #102830). Work under this Project to include erosion control measures, constructing sedimentation manholes, sump shallowing and green street facilities throughout east Portland. Ordinance Number 186695 adopted June 25, 2014 authorized a contract and provided for payment for the UIC Category 3 Retrofit Project.

DEQ requires that all UICs within 500 feet of a drinking or irrigation well have a minimum five feet of separation between the bottom of the UIC and seasonal high groundwater. Furthermore DEQ requires that all other existing UICs that currently do not have a minimum of five feet of separation between the bottom of the UIC and seasonal high groundwater should include pretreatment prior to injection into the subsurface.

8. <u>FINANCIAL IMPACT</u>: The engineer's estimate for this project was \$870,000.00 and the confidence level was Optimal. Funds are available in the Sewer System Operating Fund, FY 2014/2015 Budget, Bureau of Environmental Services, WBS Element E10570.
