Subject: Appointment and Reappointments to the Adjustment Committee

Appointment

Land Use Services Division Manager Rebecca Esau and Section Manager Douglas Hardy reviewed four Interest Forms that were ultimately submitted to the Office of Neighborhood Involvement (ONI) in response to the Media Advisory that was sent out earlier this summer seeking replacement members for two open seats on the Adjustment Committee – the Engineering, Financing, Construction, Building Management or Land Development position and the Public at Large position. One candidate rose quickly to the top, **Charles Benson.**

Charles is currently an on-call planning consultant with The Village Alliance, preparing environmental review documentation to the New York City Department of City Planning, as well as, documentary research and support for place-making and streetscape improvements.

Charles has a total of 16 years professional experience in the planning field, including prior employment working for seven years as the Technical Director of Planning for AKRF, Inc. in New York City, guiding both public and private clients through the land use review process. In that role, he made presentations before the New York City Planning commission and Board of Standards and Appeals.

He has a Bachelor of Science in City & Regional Planning from California Polytechnic State University, and has completed course work at Massachusetts Institute of Technology.

I am recommending Charles be appointed to the Engineering, Financing, Construction, Building Management or Land Development position. Charles' first, 4-year term would be from October 22, 2014, through October 21, 2018.

Reappointments

There are currently two members on the Committee whose terms expired June 30, 2014: **Anyeley Hallova** and **Suzanne Zuniga**. I am recommending that both members be reappointed to the Committee.

Anyeley was first appointed to the Adjustment Committee on June 30, 2010, in the urban design, architecture or landscape architecture membership category. She brings to the Committee 10 years of real estate development experience ranging from mixed-use sustainable developments to large-scale downtown master plans. She currently is employed with Project ^, a values driven real estate developer that provides resources, practices and stewardship for its clients. She has a Bachelor of Science in Environmental Systems Technology from Cornell, and a Master of Landscape Architecture from Harvard. If reappointed, Anyeley's second term would from July 1, 2014 to expire June 30, 2018.

Suzanne has served on the Adjustment Committee since March 7, 2012 completing a vacant partial term, in the urban design, architecture or landscape architecture membership category. She has been licensed as an architect since 1994, and is currently a principal in her own firm, Suzanne Zuniga Architect LLC. Suzanne has a Bachelor of Architecture from the University of Texas at Austin, and a Master of Architecture from Yale. Her extensive portfolio in residential and commercial work, and experience with Portland Design Review and permitting processes have been invaluable to the Adjustment Committee. If reappointed, Suzanne's first full term would be from July 1, 2014 to expire June 30, 2018.

With this appointment and reappointments, the Adjustment Committee will still have one remaining vacancy in the Public at Large position. I have enclosed an updated Adjustment Committee membership list for your records.

Adjustment Committee

The Adjustment Committee, authorized under Portland City Code 33.710.070, reviews adjustment requests to the development standards of Title 33 [Planning and Zoning Regulations]. The Adjustment Committee consists of seven members, none of whom may hold public elective office. The committee must include three persons representing the public at large, two members in either urban design, architecture, or landscape architecture, and two members experienced in either engineering, financing construction, management of buildings, or land development. The members are appointed by the Mayor and confirmed by the City Council. The terms shall be a maximum of four years with a maximum of two full terms.

The Adjustment Committee meets on the first and third Tuesday of each month from 9:00 -12:00.
