- 1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating a new represented classification of Water Meter Technician I effective July 1, 2014 and retitling two existing classifications in the Water Meter Technician series to Water Meter Technician II and Water Meter Technician III.
