Authorize the Mayor to accept on behalf of the City a grant amendment from the Oregon Department of Justice Crime Victims' Services Division for the 2012-14 VOCA Non-Competitive Grant and to execute an Intergovernmental Agreement amendment.

The ODOJ will reimburse the City for approved personnel expenses for 62 percent of the personnel expenses for the Crisis Response Team's Senior Administrative Specialist/Volunteer Coordinator for 12 months. The amount will not exceed \$42,390.
